

Built with very light alloys and compounds: aluminum and polycarbonate, it fully complies with the European accident prevention regulations thanks to the blindoor system (it ensures the stop of closing action in the absence of personnel, preventing the roller shutter closing without supervision).



HIGH RESISTANCE STRUCTURE

RC3 grade anti-burglary certified according to UNI EN 1627:2011. Lexan Exell D special polycarbonate panels: UV protection, no yellowing, impacts/fire/atmospheric agents resistance.

WINDING SHAFT CONTAINER

The particular lightness even in the larger dimensions, allows the shutter to be controlled with 230V a.c. single-phase motors. The sheets are automatically rolled up inside the winding shaft container (located above the structure, in the protected area).






RESISTANT STRUCTURE

Pressure bent steel structure with orizontal laminated glass panels (16/17mm thick, P6B grade according to UNI EN 356), sliding on vertical profile-guides, protected by nylon stoppers to facilitate sliding and silent operation. Resistant to impacts and fire.



ELEGANT SHOWCASE

It rapresent an elegant entrance solution, showcase or security division for prestigious locations in areas with high architectural impact. Ideal for: retail stores, self-banking areas, airports, museums, congress centres, companies, etc.



MOTORIZED

Opening/closing shutter management through a three-phase motor with 0.75 kw power. It can be operated only by manual action (key and push-button) for safety / accident prevention normative, also equipped with an emergency button. Geared motor with electric brake (to avoid the glass sheets fall).



PANELS CONTAINER

In the upper part there is the panels compartment. It contains all panels when the shutter is open and it is equipped with two inspection doors on which there is a mechanical sensor predisposition (for alarm management unit connection).
